### **LODGING RESERVATION INFORMATION**

#### **Lodging Request Fee**

15% will be added to the total lodging cost (pretax) to confirm specific room features such as location, building or bedding

#### **No Shows**

Rooms which have been reserved and whose attendees fail to show on their scheduled day of arrival, will be billed to the individual holding the reservations for the total lodging amount for the contracted time

#### **Early Departures**

A fee of 100% of the remaining room nights lodging amount will be charged if an attendee checks out before their confirmed departure date. This may be waived for emergencies but must be authorized by Copper Mountain Resort.

#### **Individual Lodging Deposit Policy**

A 25% deposit on the entire length of stay will be required upon making reservations. The balance on the room reservation is due 14 days prior to arrival and will be automatically billed to the credit card on file.

#### **Individual Lodging Cancellation Policy**

If canceled 15 days or more prior to arrival date, refund on the deposit amount received will be made less 50%. If canceled 14 days or less prior to arrival, the individual is subject to full forfeiture of the reservation value.

#### **Arrivals/Departures**

Check-in time is 4:00 PM Check-out time is 10:00 AM. Late check-outs are not encouraged; however, these may be possible for an additional fee and are subject to availability.

#### **Taxes Surcharges**

Above lodging rates do not include applicable tax and resort surcharge. Local tax is 8.375% and the resort Surcharge is 9.9%. Each lodging reservation is responsible for the applicable tax and resort surcharge as these rates have been subject of change.

#### **Departure Clean Fee and Housekeeping Services**

A Departure Clean Fee based on lodging unit size will be added to guest's total lodging bill.

Lodging guests will not receive Housekeeping service during their stay. Additional amenities may be requested to be delivered by dialing '0'. A mid-stay clean may be scheduled for an additional fee, fees vary by unit.

#### **Forest Service Donation**

A tax-deductible donation of \$1 per room, per night will be added to your reservation to support the National Forest Foundation (NFF), a non-profit partner of the U.S. Forest Service, to support local forest conservation. For every dollar contributed by Copper lodging guests, the NFF will invest \$1.50 in on-the-ground conservation projects in the Dillon Ranger District of the White River National Forest. You may request to have this voluntary donation removed at time of booking.

#### **Cancellation Fee Waiver**

During the booking process a Group Reservations Specialist will include cancellation protection in the quoted reservation total so that the guest may be refunded payments if cancelling for a covered reason due to but not limited to injury, health, weather, road closures and job termination. If guest opts out of the cancellation protection within 14 days of arrival payments are non-refundable for any reason. The cost of this plan is 7% of the individual guest's total purchase, calculated on the pretax amount.

#### **A.D.A Units**

Powdr Copper Mountain, LLC acts as the rental management agent for many condominium units at Copper Mountain. Each owner chooses whether to place their condominium unit in the rental program. Copper Mountain and its associated condominium projects are not hotels. Because all condominium units are individually owned and are not part of a hotel, such units may or may not be configured to comply with the accessibility requirements of the Americans with Disabilities Act. The decision of whether to make a condominium unit accessible is up to each individual owner. Condominium units meeting the accessibility requirements of the Americans with Disabilities Act may be unavailable or limited in number.
